



2027 CCA Photography Research Fellowship Program Guidelines for Application

Applications to the Photography Research Fellowship Program at the CCA must be made on the designated online application portal in either English or French. The online application should be complete at the time of submission and include the following:

- **Online Application Form**
- **Research Proposal (approximately 750-1,000 words):** In addition to a description of the research project, the proposal should include a title and an outline of the state of research on the topic, a discussion of how it relates to the CCA, and a paragraph on the expected output (be it a publication curatorial project, etc.).
- **Abstract of the research proposal (approximately 250 words)**
- **Project Schedule (approximately 300 words):** The schedule should demonstrate the feasibility of the research project for a residency period of one to two months at the CCA as well as specify what forms of engagement with the CCA Collection it will generate.
- **Curriculum Vitae:** The CV should highlight current and past affiliations and positions, as well as research and other projects relevant for the application. Publications should be divided by type and listed chronologically. Projects should mention all authors and the researcher's role.
- **Short biography (approximately 80-100 words):** The biography should highlight how the proposed project relates to the applicant's past work..
- **Publications or Portfolios (max 5 MB):** one sample of written work (books, essays) or of a project (design, curatorial) that the applicant considers the most representative of their work.
- **Names of 2 Potential Referees:** These referees should be able to assess the applicant's past and current research projects. Letters of reference are not required at the time of application.

The complete application should be uploaded on the CCA application portal no later than **Friday 16 October 2026**. Documents mailed or sent electronically will not be accepted. Only applications submitted online through the CCA application portal will be accepted. Results will be communicated by December 2026.



2027 CCA Photography Research Fellowship Program Terms of Residency

Purpose of Program

The Photography Research Fellowship Program is intended to provide space and resources for innovative and advanced research as well as a forum for dialogue and exchange. Photography Research Fellows at the postdoctoral level and beyond, or with equivalent work experience, pursue individual research supported by the holdings of the CCA Library and Collection.

Commitments

Photography Research Fellows are requested to present their research at a public event, and are invited to engage in other summer activities organized at the CCA (discussion, seminars, workshops). At the end of their stay, Photography Research Fellows are asked to submit a brief written report on their residency.

Other Activities

The Photography Research Fellowship is granted for full-time independent research on the proposal submitted by the Photography Research Fellows. Other activities inconsistent with full-time research during residency at the CCA should not be undertaken.

Selection Process

Candidates are selected by a consultative committee that reviews each application. Selection criteria include the quality, originality, and relevance of the project, especially its expected intellectual contribution to the field. The length of the research period will be determined by its feasibility, also given the resources of the CCA Library and Collection.

Residency

The program accommodates Photography Research Fellows to be in residence for one to two months. The residency window is between 7 June to 30 July 2027, with prospective fellows required to accommodate a start date during the second or third week of June. In the event of a conflict with professional calendars, applicants may propose alternative dates of arrival. Photography Research Fellows are expected to be in residence at the CCA during their tenure and to be active participants in the summer events at the CCA.

Stipends

Photography Research Fellows will receive a monthly stipend of CAD 5,000. Research stipends are allocated to cover living and accommodation expenses and are appropriate to the cost of living in Montréal.



Taxation

The CCA must comply with tax regulations under Canadian and Québec law. Photography Research Fellows should note that, in some cases, research stipends may be subject to a withholding tax. Canada has signed tax treaties with several countries. Payment of income tax either in Canada and Québec and/or in the Photography Research Fellow's country of legal residence will depend on the conditions stipulated by those treaties. Photography Research Fellows that are residents of Canada must comply with Canadian tax regulations and the tax regulations of their province of residence.

Housing

Photography Research Fellows are expected to pay the cost of their accommodation from the research stipend they receive. Suggestions will be provided to find suitable housing before arrival.

Relocation

The CCA will pay for one round-trip airline ticket to Montréal in economy class for the Photography Research Fellow. Alternatively, the CCA will pay for ground transportation to Montréal, based on mileage, up to the cost of an equivalent economy-class round-trip flight.

Additional Baggage

The CCA will reimburse expenses for the shipping of necessary scholarly materials and personal items by surface or air freight to and from Montréal within the limits of a budget determined by the CCA.

Medical Insurance

The CCA does not pay for medical insurance. However, Photography Research Fellows and members of their families should be covered by medical insurance while in Montréal. The CCA can provide information regarding local insurance providers upon request.

Work Permit

Photography Research Fellows, who are not Canadian citizens, are responsible for obtaining all visas or work permits that are legally required according to their citizenship, country of residence, and the duration of their contract. Foreign citizens who already hold or will hold a work permit in Canada at the time of their application or when they plan to be in residence are responsible for checking how to obtain a legal status with the CCA. The CCA will provide assistance in applying for a visa or work permit from Immigration and Citizenship Canada.

Facilities

Photography Research Fellows will be provided with a private office and should bring their own laptop.



Renewal

CCA Photography Research Fellowships are not renewable.
